MINUTES BOARD OF TRUSTEES MEETING LORAIN COUNTY RURAL WASTEWATER DISTRICT DECEMBER 11, 2008

Call to Order:

The regular meeting of the Board of Trustees of the Lorain County Rural Wastewater District was held at the LORCO offices, 22898 West Road, Wellington, Ohio. President McConnell called the meeting to order at 7:00 p.m. with the pledge of allegiance.

Approval of Minutes:

President McConnell noted that the minutes of the regular meeting held on November 13, 2008 had been mailed to all the trustees and called for any additions or corrections. It was moved by Ernest Hartman, with a second by Scott Grills to approve the minutes as written. All voted yea. Motion carried.

Old Business:

The Executive Director noted a December 1, 2008 memo that was part of the board package, which included the draft of U.S. Army Corps of Engineers, Nationwide Permit. Also included was a copy of the Ohio EPA letter noting that the 401 Water Quality Certification Application is considered complete and a public hearing will soon be scheduled. The resizing the Phase-I contracts was explained. This action creates six collection pipe jobs versus the former three collection pipe jobs. This will enable smaller construction companies to bid and create more jobs locally.

New Business:

President McConnell informed the board that a letter of resignation had been recently received from Barb Harper, representing LaGrange Township. It is unknown at this time when the township trustees will name a replacement. McConnell also called for an Executive Committee meeting to be held January 22, 2009 at which time employee discussions will be held.

There was no legal report provided at this time.

Rich Radachi, CPA and accountant to the LORCO board reviewed the 2008 final budget. In anticipation of receiving funding for Phase I in 2008, which did not occur, the budget needed to be corrected and funding incorporated into the 2009 budget.

WHEREAS, upon receiving notification from the Ohio EPA that LORCO will receive a Permit to Install, and;

WHEREAS, to achieve better bidding it is recognized that the multiple PhaseI collection system contracts can be downsized in scope and increased in number from three (3) to six (6) contracts, with the relocation of the SR-83 force main, and;

WHEREAS, it is deemed necessary to make arrangements to advertise for construction bids in a timely manner.

NOW THEREFORE, BE IT RESOLVED by the Board of Trustees of the LORCO Rural Wastewater District that:

- Section 1. It is in the best interests of the organization to produce construction advertisement hereby amended to six contracts upon notification of the Permit to Install, and;
- Section 2. The executive director is authorized to execute such advertisement as suggested by the consulting engineering firm, and;
- Section 3. It is found and determined that all formal actions of the LORCO Board concerning and relating to the passage of this Resolution were passed in an open meeting of the Board, and that all deliberations of this Board and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

1) That in anticipation of receiving permanent construction funding with a financing guarantee from the USDA/ Rural Development, the LORCO Rural Wastewater District may be required to expend or incur cost for planning and/or fees for the purpose of making capital improvements to their wastewater collection facility, which costs expended or incurred will be considered a part of the total USDA/Rural Development construction loan and the LORCO Rural Wastewater District may claim such costs as reimbursable expenses through the loan.
