## MINUTES BOARD OF TRUSTEES MEETING LORAIN COUNTY RURAL WASTEWATER DISTRICT December 14, 2006

## Call to Order -

The regular meeting of the Board of Trustees of the Lorain County Rural Wastewater District was held at the LORCO office, 22898 West Road, Wellington Ohio. President McConnell called the meeting to order at 7:05 p.m. with the pledge of allegiance.

## Approval of the Minutes –

President McConnell noted that the minutes of the regular meeting held on November 9, 2006 were mailed to all board members and called for any corrections or additions. It was moved by Don Wittmer with a second by Ernest Hartman to approve the minutes as written. All voted yea. Motion carried.

## Old Business –

Executive Director Alspach reported receipt of the prepared contract between LORCO and GRW Engineers, Inc. to conduct a feasibility study as requested by the New Russia Township trustees for all residents of their township. A motion was made by Ernest Hartman with a second by Dominic Ferritto authorizing the President of the Board to sign the contract between LORCO and GRW Engineers, Inc. subject to legal counsel's review and approval. All voted yea. Motion carried.

The FirstMerit Financial document has been completed and approved by legal counsel and the financial advisor. This document will be sent to Kelly

Hettick at the Massillon office of USDA-Rural Development to be included with the application packet and forwarded to the state office next week.

#### New Business –

Bob Smallwood of GRW Engineers, Inc. reviewed the Phase I progress to date with design, permitting and easement acquisition, and preparation for the bidding procedure once the financing has been finalized.

President McConnell reported on a telephone conversation he had with Kelly Hettick last week in which Kelly had re-enforced his commitment to LORCO and his efforts to evaluate all information provided thus far in the application.

Policy Committee Chairman Lynch stated a joint committee meeting was held on December 7<sup>th</sup> for discussion of administrative procedures in preparation for billing, payments, and collections. Although administrative procedures do not require board action, staff requested the committees review the procedures and advise of any comments or concerns the members may have had. There will be further discussion when the time nears for billing and tap invoicing.
