Executive Director Report:

 LGIF/Poggemeyer – Heard from Matt Witter with KE McCartney that there is a manhole on the north side of SR 113 directly across from Annis Road. Flow goes from a manhole through two lift stations along SR 113 prior to discharging to a 15" sanitary sewer at the intersection of Oberlin Road and SR 113. KE McCartney is researching for the county whether or not this sanitary sewer could handle flow from South Amherst. A modification to the agreement between the County and city of Lorain would be necessary in order for flow from South Amherst to be treated by Lorain.

- Hawke Road FPA change request Received draft flow agreement from the county. Have submitted two different rounds of comments to KE McCartney. Neil Lynch expressed a concern that he believes a modification of the FPA boundary makes more sense than a flow agreement as he believes that will result in lower treatment costs for Columbia Township residents. General discussion followed.
- Received Engineering Associates preliminary engineering report from the village of West Salem regarding necessary village WWTP upgrades.
- Carrington Pointe subdivision Preconstruction meeting was held on October 7th. Underground Utilities Inc. is scheduled to start project work on October 16th.
