President McConnell reported on the Executive – Finance Audit joint committee meeting that was held on May 24, 2006. Mr. Paul Stubbins, Financial Advisor to LORCO, was on hand to give an update on the progress of securing a lendor and our progress with the guarantee loan application commitment from USDA Rural Development. - That in anticipation of receiving permanent construction funding with a financing guarantee from the USDA/ Rural Development, the LORCO Rural Wastewater District may be required to expend or incur cost for planning and/or fees for the purpose of making capital improvements to their wastewater collection facility, which costs expended or incurred will be considered a part of the total USDA/Rural Development construction loan and the LORCO Rural Wastewater District may claim such costs as reimbursable expenses through the loan.
- That it is found and determined that all formal actions of this Board of Trustees concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board of Trustees, and that all deliberations of the Board of Trustees and of any of its committees resulting in such formal action were in meetings open to the public, in compliance with the law, including Section 121.22 of the Revised Code of Ohio.

President McConnell explained that LORCO Resolution 2005-22, Section 3, contained a fixed percentage for employees' statutorily Ohio Public Employees Retirement System (OPERS) contribution. The proposed Resolution 2006-13 will comply with OPERS increasing percentage.

**Resolution 2006-13** Be it resolved by the Board of Trustees for Lorain County Rural Wastewater District to pick up the statutorily required contribution to the Ohio Public Employees Retirement System for the Employees of Lorain County Rural Wastewater District pursuant to I.R.C. section 414 (H) (2) was moved by Ernest Hartman with a second by Gerald Cowie;

WHEREAS, pursuant to federal and Ohio laws, the employees of Lorain County Rural Wastewater District could defer the federal and state income taxes on a portion of their wages or salaries if Lorain County Rural Wastewater District would "pick up" (assume and Pay) the statutorily required contribution by such elected officials and covered employees to the Ohio Public Employee Retirement System; and

WHEREAS, Lorain County Rural Wastewater District will not incur any additional costs in the deferment of federal and state income taxes.

NOW THEREFORE BE IT ORDAINED BY THE BOARD OF DIRECTORS OF LORAIN COUNTY RURAL WASTEWATER DISTRICT THAT:

Section 1: Effective June 6<sup>th</sup>, 2005 the full amount of the statutorily required contributions to the Public Employees Retirement System of Ohio shall be picked up and paid as fringe benefit by Lorain County Rural Wastewater District. This "pick up" by Lorain County Rural Wastewater District is, and shall be designated as, public employee contributions and shall be in lieu of contribution to the Ohio Public Employees Retirement System by each person within any of the classes established in Section 2 herein. No person subject to this "pick up" shall have the option of choosing to receive the statutorily required contribution to the Ohio Public Employees Retirement System

directly instead of having it "picked up" by Lorain County Rural Wastewater District or of being excluded from the "pick up".

Lorain County Rural Wastewater District shall, in reporting and making remittance to the Ohio Public Employees Retirement System report that the public employees contribution for each person subject to this "pick up" has been made as provided by the statute.

Section 2: The "pick up" by Lorain County Rural Wastewater District provided by this resolution shall apply to all persons that:

Are the Administrative Assistant to Lorain County Rural Wastewater District who are or become contributing members of the Ohio Public Employees Retirement System.

Section 3: Under the Fringe Benefit method of Employer pick up, salary is not modified, however, the employer will pay 100% of the employees statutorily required contribution to OPERS.

Section 4: The Treasurer and/or Clerk are hereby authorized and directed to implement the provisions of this Resolution to institute the "pick up", of the statutorily required contributions to the Ohio Public Employees Retirement System for those persons reflected in Section 2 herein so as to enable them to obtain the result in federal and state tax deferments and other benefits.

Section 5: That it is found and determined that all formal actions of this Board of Trustees concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board of Trustees, and that all deliberations of the Board of Trustees and of any of its committees resulting in such formal action were in meetings open to the public, in compliance with the law, including Sections 121.22 of the Revised Code of Ohio.

The vote resulted as follows: 12 Yea 0 Nay. Motion carried

Executive Director Alspach presented the administrative report detailing a review of the weekly staff report, and news articles. In addition, LORCO has entered into an agreement with Bramhall Engineers for inspection services. A field inspector will be on site for the Barrington Park subdivision in Eaton Township which is scheduled to begin construction in mid-June. Also the agreement with Seasongood & Mayer, LLC has been signed.

Administrative Assistant Haines stated that the Cash Flow Deferral Statement was included in the board packages and asked if anyone had any questions or concerns. In addition, Administrative Assistant Haines stated that preparations are underway for the LORCO exhibit at the Lorain County Fair and asked that those members who will be interested in working in the booth sign up at the July meeting so that schedules and arrangements can be ready at the August board meeting.

#### Other Business-

Before opening the floor for questions or comments from the audience, President McConnell gave an overview of the design status, financing efforts, and landowner's responsibility. The audience participation produced many questions and concerns that

were addressed by President McConnell and Executive Director Alspach and lasted for approximately an hour. They were invited to call the LORCO office at any time with any further questions or concerns.
