2. Board terms expire 3/27/25 for Camden, Carlisle, Eaton, Elyria, Grafton, & Henrietta Twp.
3. Rick Witucki activities: A) Working with RCAP to get items together for the GIS data collection project. We should be having a kickoff meeting within the next month or so. Project to be completed on or before 8/31/2025. B) Communicating with Makeever & Associates on a regular basis to get Lift Station Improvements project updates and discuss concerns. As of late last week, trees, fences and propane tanks have been removed from LS 5 and LS 3. C) Creating inventory spreadsheets and a preventive maintenance program for the equipment at Cinnamon Lake. Will be working on inventory soon. D) Working on the LORCO website. Met with Revize Government Website Solutions. Revize is the same webhost that RLCWA uses. E) Working with Makeever & Associates to write procedures for tapping our force main in Ashland County.
4. Signing Cinnamon Lake Telemetry Upgrades project contract next Tuesday.
5. Inflow and Infiltration portion of the Phase 1 ARPA project began recently using various methods to identify clean water infiltration to our collection system and plan corrective measures.
6. Will be attending Subdivision Review Subcommittee meeting on 2/25/25. Bob Yost, Hidden Lane Development is proposing to develop fifteen (15) lots on the west side of Hidden Lane in Carlisle Township.
7. Received preliminary plans for Creekwood Golf Course subdivision. John Eavenson, Perpetual Development, is proposing to install an 8" gravity sanitary sewer running south from near the border between North Ridgeville and Eaton Township. The new sewer would allow for the development of all of Creekwood Golf Course plus additional parcels to the north.
8. Working on a Facility Planning Area (FPA) change for a single parcel that is currently in North Ridgeville's FPA. The property owner granted an easement for Phase 1 construction in return for a free tap. Have been in contact with North Ridgeville and they are in support of the change.

9. Received a request from Bob Klaiber, assistant county engineer for LORCO to write a letter of support for a proposed FPA change from Lorain County/LORCO to the Village of LaGrange. One parcel owned by North Pointe LaGrange LLC is already annexed to the village while the other (with frontage on State Route 301) is still in the township with no plans to annex. This frontage parcel will be for commercial use. LaGrange Township has passed a resolution in support of the FPA change so I will be sending the requested letter.
