RESOLUTION NO. 2024-20 Approval of non-RLCWA-related June deposits and payments. It was moved by Schlechter, with a second by Frombaugh to approve the resolution. Lynch asked a question about payments to the Cinnamon Lake Association (CLA) for shared office expense. Toy answered that LORCO entered into the same arrangement for shared office services in 2017 as the Cinnamon Lake Utilities Association (CLUA) had prior to that with CLA. Toy explained that LORCO's other options would be to hire our own

staff or to contract with a different entity such as the Village of West Salem. At the present time, Toy does not recommend a different option as the current arrangement is mutually beneficial to both LORCO and CLA. The vote was as follows: 11 Yeas. 0 Nays. Motion carried.

RESOLUTION NO. 2024-21 Approval of RLCWA-related June payments. It was moved by Koch with a second by West to approve the resolution. The vote was as follows: 10 Yeas. 0 Nays. Wesemeyer abstained. Motion carried.

| LORCO - Cinnamon Lake general lift station improvements | County, Jackson Township | General lift station improvements to Lift Station Nos. 1, 3, 5, 6, 7, & 8. Detailed plans and Permit to Install (PTI) application submitted to Ohio EPA in May 2024. On June 28, 2024, Ohio Governor Mike DeWine signed House Bill 2 appropriating \$717.8 million for One Time Strategic Community Investments (OTSCIF). With assistance from State Sen. Mark Romanchuk's office, LORCO was awarded a \$1 million OTSCIF grant for the LORCO - Cinnamon Lake General Lift Station Improvements project. The Ohio Office of Budget and Management (OBM) is administering the OTSCIF grant program and will be opening the system to access funding by mid-July. Next steps for LORCO - obtain PTI from Ohio EPA and start project bidding process. |
| LORCO - Cinnamon Lake lift station SCADA (supervisory control and data acquisition) remote monitoring | Cinnamon Lake - Ashland County, Jackson Township | Connect LORCO-Cinnamon Lake lift stations to the Village of West Salem treatment plant, lift stations, and well field SCADA system. New system will be cellular and will sync with West Salem's system. Current system is radio-based and relies on a radio receiver device connected to a computer at Cinnamon Lake to turn a lift station alarm radio signal into a telephone signal that then makes a call to the emergency on-call maintenance person. Approximately \$75,000 project will be paid for using remaining \$500,000 ARPA grant funding received from the Ashland County Commissioners. Waiting on legal opinion from DGMP Law regarding bidding requirements/process. |
